### Overview

Olga practices energy law with an emphasis on oil and gas litigation, complex commercial litigation, and regulatory matters in front of the Texas Railroad Commission. She advises operators, landowners, disposal solution providers, wastewater treatment companies, and other energy clients in regulatory and litigation matters and appeals in state and federal appellate courts.
