### Overview

Santosh Aravind, a former federal prosecutor, is an experienced trial and appellate lawyer who represents individuals and companies in white-collar criminal investigations, regulatory enforcement proceedings, cyber-security matters, and complex commercial litigation. Santosh has represented individuals and companies in proceedings brought by the Securities and Exchange Commission, the United States Department of Justice, the Office of Attorney General in Texas, Massachusetts Attorney General's Office, and various state agencies in Texas. He has chaired or co-chaired 15 trials, including nine as a former federal prosecutor in New York City, and has briefed and argued numerous appeals before the Second Circuit Court of Appeals and Fifth Circuit Court of Appeals, as well as state appellate courts in Texas. Santosh also regularly advises start-up technology companies, oil and gas companies, and individuals and companies involved in business disputes.

Before joining Scott Douglass & McConnico, Santosh served as an Assistant United States Attorney for the Southern District of New York for over five years. While a federal prosecutor, Santosh investigated and prosecuted a variety of offenses including securities fraud, bank fraud, tax fraud, murder, racketeering, weapons and international narcotics trafficking, international money laundering, public corruption, and organized crime.

From 2005 to 2009, Santosh was an associate in the litigation department in the New York office of Latham & Watkins, LLP. At Latham, Santosh represented individuals and defendants in securities and complex commercial litigation and government investigations.

After graduating from Yale University and the University of Michigan Law School, Santosh served as a law clerk for the Honorable Julian Abele Cook, Jr. in the United States District Court for the Eastern District of Michigan from 2003 to 2005.

#### Representative Criminal and Enforcement Matters

Represented an individual employee of software company in U.S. Department of Justice (“DOJ”) investigation into compliance with export control regulations relating to certain business transactions with Chinese company and affiliates. DOJ declined prosecution of employee.

After suing neighboring property owner for negligence, trespass, and other claims, client secured a comprehensive victory following a jury trial in Travis County District Court.

Counsel for global online travel company and affiliates in multiple actions pending in Florida and Delaware involving claims under the Helms-Burton Act for alleged trafficking in real property confiscated by the Cuban government. Santosh argued against class certification in one matter, leading the district court to deny plaintiff’s motion for partial class certification.

Trial counsel in representing a publicly-traded oil and gas company in a jury trial in Karnes County, which resulted in a comprehensive jury verdict for the company.
