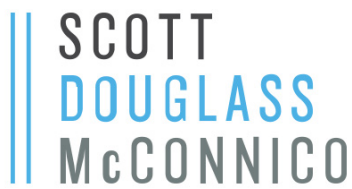
### **Representative Matters**
